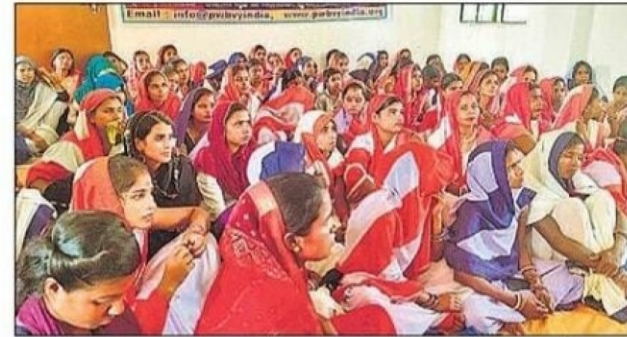
34 सेविकाओं से किया शोकाँज
